

2018 Election Day Voting Guidelines



In the register, but forgot your ID? No problem, just ask for the "Oath of Identification" form and vote on the machine

2018 – Oath of Identification

During 2018, this form may be used to verify identity by voters that are pre-registered in the precinct who are unable to produce acceptable identification at the time of voting at the polls.

Iowa voters will be required to show a driver's license, non-operator's ID, passport, military ID, veterans ID, or voter ID card at the polls before they vote. Voters without an ID may cast a provisional ballot or have another registered voter attest to their identification.
