**PUBLIC NOTICE** is hereby given to the qualified electors of the County of Polk, State of Iowa, that the General Election has been called and ordered to be held on Tuesday, November 6, 2018 at the polling places listed within this notice. A list of the names of all candidates, and the office each seeks, and a ballot to be used at this election shall be published within this notice.

**The polls will be open from 7:00 AM until 9:00 PM as provided by law.**

All voters are advised as to the requirements of voter registration in order to be eligible to vote at said election. Any voter who is physically unable to enter a polling place has the right to vote in the voter's vehicle. Electors with a disability that need an accommodation to participate in this election should contact the Polk County Election Office prior to Election Day at 286-3247 or Email [election@polkcountyiowa.gov](mailto:election@polkcountyiowa.gov) for assistance. Machine testing is being held at the Polk County Election Office and at all precincts that commenced on October 15, 2018 through November 5, 2018.

For elections held in 2018, pre-registered voters are required to provide an approved form of identification or sign an oath of identification at the polling place before receiving and casting a ballot. Voters who are not pre-registered – such as voters registering to vote on Election Day – and voters who have changed precincts will also be required to provide proof of residence. A voter who cannot provide proof of identification may have their identity attested to by another voter registered in the precinct who has an approved form of identification. Starting January 1, 2019, all voters will be required to present an approved form of identification.
