SPECIAL LOCAL OPTION SALES AND SERVICE TAX ELECTION

PUBLIC NOTICE OF ELECTION is hereby given pursuant to Iowa Code Chapter 423B you are hereby notified that on March 5, 2019 an election will be held in the City of Altoona to vote on the question of imposition of a Local Option Sales and Services tax. The Proposal to be voted upon at this election will be in substantially the form listed within this publication.

Imposition question for voters in City of Altoona, in the County of Polk, State of Iowa, will be voting on Public Measure Letter A.

The polls will be open from 7:00 AM until 8:00 PM at the following Polling Places:

Any voter who is physically unable to enter a polling place has the right to vote in the voter's vehicle. For further information, please contact the Polk County Election Office at 286-3247 or election@polkcountyiowa.gov. Public Machine testing will commence Tuesday, February 19 and continue until Monday, March 4 at each precinct.

Pre-registered voters are required to provide an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered – such as voters registering to vote on Election Day – and voters changing precincts must also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence if required) 1) may have the voter's identity/residence attested to by another registered voter in the precinct, 2) prove identity and residence using Election Day Registration documents, or 3) cast a provisional ballot and provide proof of identity/residence at the county auditor's office by Noon, March 7th. Election Day Registrant attestors must provide an approved form of identification. All qualified electors of the City of Altoona are hereby notified to appear at said time and place, vote at the polling place designated, and advised as to the requirements of voter registration in order to be eligible to vote as authorized by law.
