Public Machine testing will commence Tuesday, October 1 and continue until Monday, October 7 at each precinct. Public Machine testing for Dallas County Precincts will begin on Wednesday, September 25 @10am until completed.

Pre-registered voters are required to provide an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered – such as voters registering to vote on Election Day – and voters changing precincts must also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence if required) 1) may have the voter's identity/residence attested to by another registered voter in the precinct, 2) prove identity and residence using Election Day Registration documents, or 3) cast a provisional ballot and provide proof of identity/residence at the county auditor's office by Noon, October 10th. Election Day Registrant attestors must provide an approved form of identification. All qualified electors of the City of Urbandale are hereby notified to appear at said time and place, vote at the polling place designated, and advised as to the requirements of voter registration in order to be eligible to vote as authorized by law.
